As a service to our authors, LWW will identify to the National Library of Medicine (NLM) articles that require deposit and will transmit the post-print of an article based on research funded in whole or in part by the National Institutes of Health, Wellcome Trust, Howard Hughes Medical Institute, or other funding agencies to PubMed Central. The revised Copyright Transfer Agreement provides the mechanism.

Authors when submitting their manuscripts to PubMed Central or repositories of other funding bodies are required to specify a time-frame for the availability of their article to the public on PubMedCentral. The AHA permits, and requires, that the time frame you specify is no earlier than 6 months after publication in the AHA journal. The copyright transfer agreement you sign gives you the rights to make the accepted article public on a repository such as PubMed Central no earlier than 6 months after publication. This will meet the NIH request to make articles funded in whole or part by NIH funds publicly available and meet the requests of most funding bodies, but please check your requirements carefully. Additionally, when the editor requests the final revision of your manuscript, you will be required to insert the following language on the title page:

This is an un-copyedited author manuscript that was accepted for publication in (journal name), copyright The American Heart Association. This may not be duplicated or reproduced, other than for personal use or within the "Fair Use of Copyrighted Materials" (section 107, title 17, U.S. Code) without prior permission of the copyright owner, The American Heart Association. The final copyedited article, which is the version of record, can be found at (journal URL). The American Heart Association disclaims any responsibility or liability for errors or omissions in this version of the manuscript or in any version derived from it by the National Institutes of Health or other parties.

Authors whose accepted manuscripts acknowledge research funding from the National Institutes of Health (NIH) are required to submit the NIH Policy Addendum. For a complete explanation of the NIH Public Access Policy mandate and its implementation, refer to the following URL:

Upon acceptance of a manuscript that acknowledges funding from NIH, the corresponding author will be contacted and asked to complete the [NIH Policy Addendum](#) [PDF]. Author self-submits. Embargo is 12 months after publication. Stipulations: ACS shall require the NIH to ensure that the deposited version when displayed within PubMed Central carries the complete bibliographic citation of the final published article and its corresponding Digital Object Identifier (DOI) for definitive reference purposes, and that the NIH's PubMed Central provide a link to the final published version of the article at the ACS Web site. The AACR grants permission for authors who have signed our copyright transfer form to deposit their manuscripts on PMC, *without formal request or fee*, subject to the following conditions:

- Only the **accepted manuscript** is deposited, not the edited and formatted paper as published in the journal.
- Authors stipulate that PubMedCentral may release the paper for public access not sooner than **12 months after its print publication date (the print publication date is considered the official publication date, not any prior online publication of earlier versions** of the paper.
- Authors **acknowledge the published source** of the material.
- A link to the final PDF version of the article on the publisher's journal website is included.

At the time your paper is accepted for publication, you will be reminded to comply with your funding agency requirement, given a link for PMC deposit, and provided a copy or a link to the copy of the version of the paper that you are required to deposit. Because of the NIH requirement that authors verify the paper and supply various information about their funding, it is not possible at this time for AACR to make the deposit for you.

As of April 7, 2008, the final redacted versions of all research articles resulting from partial or complete support from NIH must be deposited immediately in the NIH repository, PubMed

Central. PubMed Central will not release articles to readers for 12 months. While compliance to this NIH mandate is the responsibility of the authors, ASBMB will automatically deposit articles on behalf of authors as a service.

ASBMB/JBC, as copyright holder, grants permission to all authors, for the sole purpose of compliance with the NIH request, to deposit their accepted manuscripts in PubMed Central. During submission of a manuscript for review, authors will be required to indicate whether or not the work resulted from NIH funding. If NIH funding is involved, and the paper is ultimately accepted for publication, the final redacted version will automatically and immediately be sent to the NIH on behalf of the authors. This will completely satisfy the NIH mandate and authors need do nothing else.

This service will be free for ASBMB members and will cost \$50 for non-members. The \$50 fee covers the cost to the publisher to tag and upload high resolution figures and supply supplemental data from our vendors to PubMed Central. [ASBMB membership currently costs \$140/yr and includes many additional benefits so you may wish to consider joining and receive this service free of charge. From April 2008, the NIH is mandating grant-holders to deposit their published papers in PubMed Central within 12 months of publication. *Molecular Microbiology* complies with the NIH mandate in allowing authors to post the accepted version of their article, i.e. the version incorporating any amendments made during peer review, 12 months after publication (please see the 'After acceptance' bullet points on page 1 of the Exclusive License Form for full details).

In addition, authors are encouraged to archive this version of the manuscript in their institution's repositories and, if they wish, on their personal websites, also six months after the original publication. In all these cases, authors should cite the publication reference and [DOI number](#) on any deposited version, and provide a link from it to the URL of the published article on the journal's website (see [publications A-Z index](#)).
