Dear Dr. Eckstein:

I am writing again in strong support of Dr. John O. Holloszy, whose candidacy for membership in the Central Society for Clinical Research is being reconsidered this year.

As I mentioned in my letter of March 17, 1967, I consider Dr. Holloszy an exceptionally well qualified candidate. During the past year his productivity in the laboratory has continued at a level of high quality, and has broadened to include important dietary factors in relation to the adaptive biochemical changes occurring with endurance exercise. The experimental results have important fundamental implications for the field of nutrition in general and are essential to the rational planning of endurance exercise programs in relation to obesity and cardiovascular disease.

Within the past year Dr. Holloszy has been awarded a 5 year renewal of his National Heart Institute grant for studies of exercise-induced biochemical and anatomic adaptations. Under institutional grant support he has inaugurated a clinical study of the effects of exercise on obesity and appetite. And a research grant application currently under consideration by the National Heart Institute concerns the effect of exercise on coronary disease risk factors. In September of 1967 Dr. Holloszy's research staff was strengthened by the arrival of Dr. Lawrence Oskal, and in the fall of 1968 the group will be further augmented by Dr. Paul Mole (Ph.D. in Physiology). Dr. Holloszy continues to attract an enthusiastic group of medical students to participate in his research programs during elective periods; one of the students has recently made plans to obtain a Ph.D. in addition to his M.D. degree.



I would like to propose the name of Dr. John O. Holloszy for membership in the Central Society for Clinical Research.

Dr. Holloszy is a member of the full-time staff of the Departments of Preventive Medicine and Medicine at the Washington University School of Medicine and holds faculty rank as an Assistant Professor. Following his medical training, internship and residency, he was associated with the Heart Disease Control Program of the Public Health Service and was stationed at the University of Illinois in Urbana where he participated in a study of physical training and exercise tolerance, body density, serum lipids and cardiovascular function of middle-aged males. He then for a two year period from July 1963 to June 1965 was a Special Fellow in Biological Chemistry in the department of Dr. Carl Cori at Washington University. During this fellowship he was associated with Dr. Hiromichi Narahara in a study of the effect of muscular work on sugar transport in muscle. Following this training he was appointed to his present position in which he directs a laboratory research program with NIH support entitled "Exercise Induced Biochemical and Anatomic Adaptations". These investigations have been productive of new information concerning the metabolic and enzyme adaptations which occur in the muscles of rats which are chronically exercised.

In addition to his research endeavors, Dr. Holloszy carries responsibilities as the Assistant Director of the Irene Walter Johnson Institute of Rehabilitation and is developing a new program relating to rehabilitation of patients with cardiovascular disease. He is an effective teacher of medical students and attracts many to his laboratory.

In my view he is a gifted and promising young investigator who is committed to an academic and research career. I feel that he fully merits consideration for membership in the Society and would be grateful for any consideration given this nomination.



REVISION OF CONSTITUTION

The Council has approved a revised constitution. This was presented to the membership at the annual meeting. It was moved and seconded that reading the constitution be omitted. This motion passed unanimously. Therefore, the revised constitution will be mailed to all members during the summer and action will be taken at the 1966 annual meeting. The major changes include:

1. Clarify the objectives of the Society.
2. Eliminate the requirement to be a member of the county and state medical society.
3. Elimination of adjunct category. Candidates with a Ph.D. degree would be eligible for active membership if they are doing clinical investigation. Present adjunct members would then be eligible for active or emeritus status.
4. Extension of the geographic limits to include West Virginia and Western Pennsylvania.
5. Extension of the years of active membership from 10 to 15 to be eligible for election to emeritus status.
6. Add the Editor of the Journal to the Council.
7. Include provision for forfeiture of membership after failure to pay dues for two years.

Both the proposer and the seconder must submit ELEVEN COPIES of a letter detailing qualifications, achievements, and current activities of the candidate. This will facilitate the review of proposals by each member of the Council. In the bibliography, abstracts should be listed separately and identified as abstracts. Application blanks may be obtained from the Secretary. A list of candidates will be mailed to you before the Council meets in September. According to the constitution no one may be admitted to membership after the age of 45. Qualified individuals who are more than 45 years of age may be nominated for adjunct membership.

MEMBERSHIP CANDIDATES - PROPOSED IN 1964 and 1965

Action was deferred in a number of candidates proposed for membership in 1964 and 1965. It is requested that each proposer bring this application up to date. New material should be submitted by May 1. The bibliography should be complete and abstracts listed separately. Please send ELEVEN COPIES of all material.

NOTE

EMERITUS MEMBERSHIP

Members eligible for emeritus membership are transferred to this status only upon request. Unless such a request is made, members are carried on an active basis. Members may request emeritus membership only after 10 years as an active member in good standing. Action on transfer from active to emeritus status cannot be taken for the current year in which it is requested. Consequently, dues are to be paid by those members since they are considered as active members until the following year.

SCIENTIFIC EXHIBITS

This coming year we will have technical exhibits again. In addition members may submit proposals for scientific exhibits. Exhibits should be new material that cannot be presented well verbally. Strict adherence to this ruling is essential because the time for preparation of abstracts for publishing is extremely short this year. It will be impossible to contact authors for additional data. There will be no opportunity to alter abstracts after submission.

Maximum Length - 350 words. The Council has ruled that abstracts containing more than this number of words will not be published. Please place the total number of words at the bottom of the first page. Additional information, which might aid the Council in its selection of papers for the program, may be submitted in the form of a letter. It will not be published.

Because of the large number of abstracts submitted the past few years the Council passed the following resolution at its last meeting:
"Members may be authors or co-authors of papers, and may introduce papers by non-members. However, no member may submit more than one title, introduce more than one paper by non-members, or when submitting a title himself introduce a title by non-members. A member may, while submitting a title himself or while introducing a title by non-members, have his name appear as co-author on a title submitted by another member."

SIX COPIES OF EACH ABSTRACT AND LETTER are requested. Abstracts are distributed to members of the Council for review prior to the meeting of this group.

Central Society For Clinical Research

CONSTITUTION

As finally corrected and adopted in November, 1936

* * *

Article I

N A M E. The name of the Society shall be the Central Society for Clinical Research.

Article II

OBJECTS. The object of this Society shall be the cultivation of Clinical Research and the development of the younger men in the territory covered.

Article III

Section 1. TYPES OF MEMBERS. There shall be three types of members: Active, adjunct and emeritus.

Section 2. ELIGIBILITY OF MEMBERS.

- A. Active Members. Any practising physician who is a member of his County and State Medical Society, or anyone engaged in closely allied sciences residing in the territory concerned, who has accomplished a meritorious original investigation in the clinical or allied sciences of medicine and who enjoys an unimpeachable moral standing in his profession, is eligible to active membership. No one shall be admitted to active membership over the age of forty-five years. The number of active members shall be determined from time to time by action of the Council.
- B. Adjunct Members. (a) An adjunct member may be elected at the desire of the Society and by recommendation of the Council from that group of men who are over forty-five years of age but who are eligible for active membership in every other respect. (b) And from those groups, irrespective of age, which are engaged in research or teaching in the medical and allied sciences but who are not engaged in active clinical medicine.
- C. Emeritus Members. A member may become an emeritus member upon application to the Council, if he desires, after being an active member of the Society in good standing for ten years. Upon Council action an active member eligible for emeritus membership may arbitrarily be placed upon the emeritus list.

Section 3. OBLIGATIONS OF MEMBERS.

- A. Active Members. Active members must manifest a continuous interest in the objects of the Society by (1) presenting reports to the Society or by submitting satisfactory evidences of continued activity in clinical research to the Council at least once in three years; (2) by attending at least every other annual meeting. The neglect of either of these two obligations, without an explanation acceptable to the Council, carries with it forfeiture of membership; (3) by being active in the diffusion of the principles of the Society, particularly among the students who come under their care.

CONSTITUTION (Continued)

- B. Adjunct Members. Adjunct members may engage in all activities of the Society, including presentation of papers; discussion of papers on the floor; nomination of new members and the like. They shall not hold office or have the power to vote nor are they obliged to pay dues. Their attendance and participation in the meetings is urged but not compulsory.
- C. Emeritus Members. Emeritus members may engage in all activities of the Society, including presentation of papers, discussion of papers on the floor, nomination of new members and the like. They may hold office and have the power to vote but shall not be obliged to pay dues. Their attendance and participation in the meetings is urged but is not compulsory.

Section 4. NOMINATIONS AND ELECTIONS.

Nominations to active and adjunct membership may be made in writing to the Secretary at any time. Nominations must be signed by two members, who are not officers of the Society, and must be accompanied by a statement of the qualifications of the nominee and a list of his professional positions and publications. All names thus placed in nomination two months prior to each annual meeting shall be considered by the Council, which shall pass upon the qualifications of the candidates and report to the Society for election at the annual meeting such names as it shall approve by a two-thirds vote. An affirmative vote of at least three-fourths of the members present shall be necessary for election. The Council shall determine whether such nominees shall be admitted as active or as adjunct members. The Council shall also report to the Society a list of candidates whose names shall be continued in nomination. The Council may at its discretion drop the names of nominees.

Section 5. EXPULSION.

Membership may be forfeited also for reasons mentioned especially or not mentioned in the Constitution, after consideration of the Council by a three-fourths vote of the total membership. The vote shall be by secret ballot at an annual meeting or by mail.

Article IV

OFFICERS

Officers of the Society shall be a President, Vice-President and a Secretary-Treasurer, all to be elected annually. In addition, each year two Councilors shall be elected to serve three years. There shall not be more than one Councilor from a given city. All officers are ineligible for re-election in the same office except the Secretary-Treasurer. These officers are to be nominated by a committee of three appointed by the President, and the election shall be by secret ballot. Officers and Councilors may be elected from both the active and emeritus groups of members.

Article V

DUTY OF OFFICERS

The duties of the President, Vice-President, Secretary-Treasurer, shall be those usually assigned to the offices. The Secretary shall also arrange for the publication of abstracts of papers presented at the meetings.



ANNUAL MEETING

In 1957 the meeting will again be held the first Friday and Saturday of November. Reservations for rooms should be made as far in advance as possible. Requests for reservations should clearly state that you wish to attend the meeting of the Central Society for Clinical Research.

Six copies of each abstract are requested and they must not exceed 350 words. According to the recent motion passed by the Council, "MEMBERS MAY BE AUTHORS OR CO-AUTHORS OF PAPERS, AND MAY INTRODUCE PAPERS BY NON-MEMBERS. HOWEVER, NO MEMBER MAY SUBMIT MORE THAN ONE TITLE, INTRODUCE MORE THAN ONE PAPER BY NON-MEMBERS, OR WHEN SUBMITTING A TITLE HIMSELF INTRODUCE A TITLE BY NON-MEMBERS. Dr. Loosli was thanked by the Society for the excellent job that he had done as Editor of the Journal of Laboratory and Clinical Medicine. I am enclosing a copy of a letter I recently received from the third member of our Committee, so you can see how we are progressing in preparing our slate for the Central Society. It is clear that Jerry Conn will be recommended for the Presidency.

The choice of the Vice-President is not unanimous. I would be quite willing to pass up both Heinle and Sprague and recommend Clayton Loosli for this place. His proven interest in the Society, as well as his residence in Chicago, make him an excellent person for this office, in my opinion. I prefer Loosli to Irvine Page but would not oppose him if both of you prefer Page. Heinle has left Cleveland, I believe, and this may be a good time not to pick one of the retiring Councilors for the Vice-Presidency.

I have talked (confidentially) with a few members of the Society about a Secretary-Treasurer, and all are strong for Robert Ebert if he will accept the job. I don't think his position as Associate Editor of the Journal should influence us if we really think he is the man for the job. He might wish to resign the Editorship should he accept the position as Secretary-Treasurer, but the Society would still profit in all probability. I think the other suggestions you made, i.e., Drs. Rammelkamp, Thomas and Vilter, are good ones (especially Dr. Thomas) but I don't think it would be wise for us to select one of our Committee for any of the positions under consideration. Maybe this is one of the penalties of serving on a Nominating Committee.

Should we agree on Clayton Loosli for the Vice-Presidency, neither of the Councilors should come from Chicago. I think we do agree that one should reside in Wisconsin, and either Dr. Gordon of Madison or Dr. Rosenbaum of Milwaukee would, in my opinion, be excellent. Dr. Gordon B. Myers of Detroit would be good for the other Councilor, and I would favor him over Dr. Rammelkamp, since Cleveland has been represented (by Dr. Heinle) so recently.

Please let me know what you think about our mutual problems. I think no one can be given a final nomination for the Secretary-Treasurership by our Committee until he has been approached and has agreed to serve. Most of our Secretary-Treasurers have held the position for several years, and I

Dear Dr. Johnston:

After further thought concerning nominations for offices in the Central Society, I would like to make a number of suggestions:

1) I would like to reaffirm my support of Dr. Jerome Conn for the presidency.

2) In consideration of the names of the two retiring members of the council as possible nominees for the vice-presidency, I feel that Dr. Randall Sprague is deserving of this recognition and I would prefer this nomination to that of Dr. Robert Heinle. However, I would like to make two other suggestions. The first is that of Dr. Clayton Loosli. He has been very active in concerns of the Society and merits this recognition. It is true that he still serves as Editor of the Journal of Laboratory and Clinical Medicine. I do not think that this should interfere with this nomination. If I recall correctly, Dr. Eugene Ferris served as president of the Society for Clinical Investigation while also active as Editor of that Journal. Aside from consideration of this nomination in terms of the contributions which Dr. Loosli has made, it would have the added advantage of giving the office of president to Chicago, an honor that this city has apparently not had in many years (i.e., if the custom is followed of elevating the vice-president to the office of president in the succeeding year.)

The second suggestion is that of Dr. Irvine Page. He has been active in the Society for a long period, has carried on an active program of research, and is a former member of the Council. So far as I know, he has not been similarly honored by other societies and merits consideration for this office by the Central Society. I would endorse his candidacy but realize that others might not be so motivated.

3) For the office of Secretary-Treasurer I think that it would be an imposition to ask Dr. Robert Ebert to serve both as Associate Editor of the Journal and as Secretary-Treasurer. Dr. Landau might fill the position effectively but since I am not acquainted with him, I can make no judgment of my own. Wondering how imperative it is to fill this position from within the vicinity of Chicago and in the effort to afford other suggestions, I would like to propose the names of Dr. Lewis Thomas of Minneapolis, Dr. Richard Vilter of Cincinnati, and Dr. Charles Rommelkamp of Cleveland. I think that anyone of these men would fill this position most creditably. Furthermore, I do not think that Dr. Thomas' name should be withheld from consideration simply because he is a member of our committee.

4) For consideration for nominations to the Council I would like to propose four names. They are Dr. Edgar Gordon of Madison, Dr. Charles Rommelkamp of Cleveland, Dr. Harry F. Dowling of Chicago, and Dr. Gordon Myers of Detroit. Each of these men are from cities not now represented on the Council and in my opinion each would contribute importantly to deliberations of the Council.

The names recorded above are of men who are either emeritus members or soon to achieve that "distinction". I have the feeling that the Society might be well advised to elect a number of younger men to the Council. Two persons who merit this consideration in my opinion are Dr. Lewis Thomas and Dr. Richard Vilter, names which I have already mentioned for the office of secretary. Perhaps there are others of similar stature. Suffice it to say that I would be pleased to give my support to a qualified younger person.

Your letter arrived while I was on vacation in New Hampshire and has been forwarded to me. I am sending this reply through my office.

The considerations placed before our nominating committee are important ones and I would hesitate to commit myself to decisions at this distance and apart from my files. For instance, I do not recall the entire membership of the current Council. I would, however, like to record these comments:

1. I would be in accord with the nomination of Dr. Jerome Conn for the presidency.

2. In selection of a candidate for the vice-presidency I would hope that the person selected should achieve this recognition through the merits of his research and not so importantly through his site of residence. Along this line I think that I am correct in stating that Bob Heinle no longer is in Cleveland but has moved from Western Reserve to take up association with one of the drug houses--either Upjohn or Parke-Davis, as I recall.

3. Designation of a secretary-treasurer seems to me to be our most important task. In this regard I would like the advice of some of the former officers of the society. Of the names you have proposed I would think that Dr. Ebert could and would fill this office effectively. I do not know Landau well enough to comment. I would like to have further information about each of these and others before anyone is approached. This matter may be of sufficient importance to warrant a meeting of the Committee.

4. I would like the opportunity for further consideration before suggesting the names of specific individuals for membership on the Council.

I am afraid that my comments do not at this time add up to anything which is constructive or helpful. I record them just to give you my present thoughts and will write again after my return to St. Louis.

Dear Doctor Shank:

As you know, Dr. Lewis Thomas you and I have been asked by Dr. George Burch, President of the Central Society for Clinical Research, to serve on the Nominating Committee this year. Since we are asked to make our selections before the next meeting of the Council on September 26, and vacations so often slow things at this time of year, I am writing you now to get your suggestions about the slate we should present. Dr. Kohlstaedt sent more information to me than he did to you and, since some of this may aid you, I am passing this along. I quote from his letter:

"It has been customary to select the vice-president from the retiring members of the Council; however, this decision is entirely a matter for your Committee. There are no established policies. Emeritus members may serve as officers of the Society. It will be necessary for your Committee to select a president, and you will note that during the past several years, it has been the custom to advance the vice-president to president. We will need two new Council members to replace Dr. Robert Heinle and Dr. Randall Sprague.

I would like to be relieved of my duties as secretary-treasurer. I have held this office for five years, and I believe that this is the maximum time any officer should hold office in a society. It would be advantageous to have the office of secretary in Chicago. Dr. Clayton Loosli suggests Dr. Robert Ebert and Dr. Richard L. Landau, both of the Department of Medicine of the University of Chicago. He feels that Dr. Landau would have more time to devote to the office. I have developed an addressograph file, and I think the secretary should be selected from a city in which letter service would be available. The Society is allowed \$70.00 per month for secretarial help. I believe you should have this information before you approach any perspective candidate for the position. The position is not difficult, and if adequate secretarial assistance is available, it would not require very much time."

In making our selections, I am sure you will agree that we should pay attention to the geographical region from which our officers and councilors come, as well as their fitness in other respects.

Unless you feel there is some reason to break with tradition, it seems that our task in selection of the president is simple. Do you think that we should present the name of Dr. Jerome W. Conn, the present vice-president, or do you have other suggestions?

As Dr. Kohlstaedt points out in his letter, it has been customary to choose one of the retiring councilors for the vice-presidency. If we follow this, the choice will be between Dr. Robert Heinle and Randall Sprague. I have no strong preference for either of these men, but since Sprague is from Rochester and the Mayo Clinic group has had a president more recently (Ed Allen-1948) than has Cleveland (Roy Scott-1945), I would be inclined to give the nod to Heinle. Do you agree with this? Do you have suggestions apart from either Sprague or Heinle for the vice-presidency?


If we pick councilors partly because they may later be selected for the presidency, it seems to me that one of the men we choose should be from Wisconsin. There has only been one president from that state (Middleton in 1933), and the last councilor from Wisconsin was Ovid Meyer in 1942. I suggest Edgar S. Gordon of Madison, or Francis F. Rosenbaum of Milwaukee as possible candidates. Considering the large membership from Chicago, it is my impression that this city has not been adequately represented either by officers or council members in the past and wonder if it might not be a good idea to nominate someone from Chicago for the other councilor and suggest Ford K. Hick. Dr. Hick served as secretary-treasurer of the Society a few years ago, and this experience and his long membership in the Organization would make him of particular value on the Council. He would also make a fine president, should things turn out that way in the future. Please don't misunderstand my specific suggestions relative to personnel for our slate. They are only suggestions, and I am not trying to dominate our Committee. The slate we present must represent the views of the entire Committee, and I am only trying to start things moving.

I am sorry that Dr. Kohlstaedt wishes to give up his job as secretary-treasurer. It is a very important post in our Organization, and in choosing his successor we should select a man who is not only an interested active member but one who will be willing to keep the position for several years. I agree with Dr. Kohlstaedt that there are advantages in having a secretary-treasurer from Chicago, but do not think this is at all necessary. How do you feel about this matter? Do you think either Dr. Robert Ebert or Dr. Richard Landau would be a good man for the job, or do you have other ideas? I think the selection of a new secretary-treasurer is probably our most important and urgent task. The individual we agree upon certainly must be contacted and be willing to serve before the deal can be closed.

Please let me have your suggestions relative to the above matters as soon as possible.



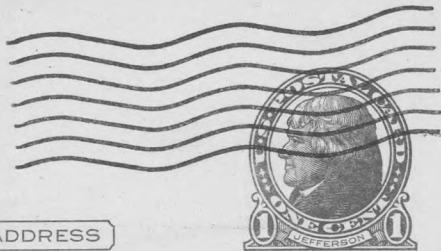

Section 2. ELIGIBILITY OF MEMBERS

A. ACTIVE MEMBERS. Any practising physician who is a member of his County and State Medical Society, or anyone engaged in closely allied sciences residing in the territory concerned, who has accomplished a meritorious original investigation in the clinical or allied sciences of medicine and who enjoys an unimpeachable moral standing in his profession, is eligible to active membership. No one shall be admitted to active membership over the age of forty-five years. The number of active members shall be determined from time to time by action of the Council.

B. ADJUNCT MEMBERS. (a) An adjunct member may be elected at the desire of the Society and by recommendation of the Council from that group of men who are over forty-five years of age but who are eligible for active membership in every other respect.

(b) And from those groups, irrespective of age, which are engaged in research or teaching in the medical and allied sciences but who are not engaged in active clinical medicine.

C. EMERITUS MEMBERS. A member may become an emeritus member upon application to the Council, if he desires, after being an active member of the Society in good standing for ten years. Upon Council action an active member eligible for emeritus membership may arbitrarily be placed upon the emeritus list.

Section 3. OBLIGATIONS OF MEMBERS

A. ACTIVE MEMBERS. Active members must manifest a continuous interest in the objects of the Society by (1) presenting reports to the Society or by submitting satisfactory evidence of continued activity in clinical research to the Council at least once in three years; (2) by attending at least every other annual meeting. The neglect of either of these two obligations, without an explanation acceptable to the Council, carries with it forfeiture of membership; (3) by being active in the diffusion of the principles of the Society, particularly among the students who come under their care.

B. ADJUNCT MEMBERS. Adjunct members may engage in all activities of the Society, including presentation of papers; discussion of papers on the floor; nomination of new members and the like. They shall not hold office or have the power to vote nor are they obliged to pay dues. Their attendance and participation in the meetings is urged but not compulsory.

C. EMERITUS MEMBERS. Emeritus members may engage in all activities of the Society, including presentation of papers, discussion of papers on the floor, nomination of new members and the like. Section 2. ELIGIBILITY OF MEMBERS

A. ACTIVE MEMBERS. Any practising physician who is a member of his County and State Medical Society, or anyone engaged in closely allied sciences residing in the territory concerned, who has accomplished a meritorious original investigation in the clinical or allied sciences of medicine and who enjoys an unimpeachable moral standing in his profession, is eligible to active membership. No one shall be admitted to active membership over the age of forty-five years. The number of active members shall be determined from time to time by action of the Council.

B. ADJUNCT MEMBERS. (a) An adjunct member may be elected at the desire of the Society and by recommendation of the Council from that group of men who are over forty-five years of age but who are eligible for active membership in every other respect.

(b) And from those groups, irrespective of age, which are engaged in research or teaching in the medical and allied sciences but who are not engaged in active clinical medicine.

C. EMERITUS MEMBERS. A member may become an emeritus member upon application to the Council, if he desires, after being an active member of the Society in good standing for ten years. Upon Council action an active member eligible for emeritus membership may arbitrarily be placed upon the emeritus list.

Section 3. OBLIGATIONS OF MEMBERS

A. ACTIVE MEMBERS. Active members must manifest a continuous interest in the objects of the Society by (1) presenting reports to the Society or by submitting satisfactory evidence of continued activity in clinical research to the Council at least once in three years; (2) by attending at least every other annual meeting. The neglect of either of these two obligations, without an explanation acceptable to the Council, carries with it forfeiture of membership; (3) by being active in the diffusion of the principles of the Society, particularly among the students who come under their care.

B. ADJUNCT MEMBERS. Adjunct members may engage in all activities of the Society, including presentation of papers; discussion of papers on the floor; nomination of new members and the like. They shall not hold office or have the power to vote nor are they obliged to pay dues. Their attendance and participation in the meetings is urged but not compulsory.

C. EMERITUS MEMBERS. Emeritus members may engage in all activities of the Society, including presentation of papers, discussion of papers on the floor, nomination of new members and the like. They may hold office and have the power to vote but shall not be obliged to pay dues. Their attendance and participation in the meetings is urged but is not compulsory.
